CCWD Overview

- Organized in 1946
- Special district
- Calaveras County
 - 1,080 square miles
 - Mostly rural
 - Population of 46,000
 - CCWD serves 22,000 people
 - 13,000 water cust.
- Three watersheds:
 - Mokelumne River
 - Calaveras River
 - Stanislaus River

- Rate increases took place in fall 2013 and 2014
- Board postponed in 2015 increase and cancelled it in 2016
- All rate increase funds reserved for the Capital Renovation and Replacement Program (Capital R&R)
- These funds pay for critical water and sewer projects throughout the County

Capital R&R Program

- Total CCWD assets: in excess of \$100 million
- Five-year CIP plan (adopted in 2016)
 - \$28 million in water projects identified
 - \$11 million in wastewater projects identified
- Infrastructure generally lasts between 15 and 50 years
- R&R Program addresses the most critical needs to address biggest challenges like failing

- Jenny Lind Water Treatment Plant Pretreatment
 - Construction summer 2016
- Big Trees Redwood Tanks Replacement

- <u>Reach 3A Pipeline Replacement</u>
 - Construction spring/summer 2016

Reach 3A Project Planning

- Project first proposed in 2013
- Very complex project
- USDA grant/loan
- Coordination with Army Corps, Dept. of Fish and Wildlife, Caltrans, Cal Fire, Cal. County Public Works
- Right of way, private property, golf course
- Careful planning to minimize customer impacts in populated area



Project Schedule

- Sept. Oct. 2015 / Final Plans
- Nov. 2015 Jan. 2016 / Bid Project
- Feb. April 2016 / Award Contract
- Feb. May 2016 / Finalize USDA Grant/Loan
- May. 2016 / Notice to Proceed
- May. Nov. 2016 / Construction

Project Overview

- 12-inch Ductile Iron / 250 to 300-psi
- 3.75 Miles (20,000 feet) with 16 PRV Stations
- Old pipeline built 1965 New pipeline should last 75 years
- Starts at Cal-Fire Station, ends at Sawmill Tank
 - Tunnel under Hwy 4
- Strive to not interrupt water service for more than 1 day
 - Isolation valves installed over past year


